# **POSITION DESCRIPTION:**

Reporting to the Director of Food Safety and Facilities, the Facilities: Material Handling & Maintenance staff play a vital role in ensuring all departments have an adequate supply of clean, well-maintained materials essential for daily operations. This position involves monitoring inventory levels, upholding cleaning standards, and efficiently distributing materials to the appropriate departments. Collaboration with volunteers and cross-departmental teams is a key aspect of the role. Additionally, a portion of their time will be dedicated to supporting minor maintenance projects.

#### **ESSENTIAL JOB FUNCTIONS:**

- Strong communication skills must be able to effectively explain daily projects to volunteers
- Ability to work cross departmentally
- Monitor and maintain inventory levels of materials to ensure sufficient supply for all departments
- Ensure all materials meet hygiene and safety standards
- Organize milk crates to prepare for cleaning
- Clean milk crates and bins
- Inspect banana boxes for reuse
- Completes all assignments listed on Master Cleaning Schedule in a timely & exceptional manner
- Perform extra cleaning duties as instructed by Director of Food Safety and Facilities
- Operates pallet jacks, forklifts, scissor lift and other related warehouse equipment
- Facility upkeep repairing or patching walls, painting, assembling or disassembling furniture

## PHYSICAL DEMANDS/ENVIRONMENTAL FACTORS:

- Regularly required to lift and carry up to 50 lbs (cart or equipment to assist is provided)
- Regularly required to stand, reach, and use hands
- Regularly required to move, push, or pull up to 2,000 lbs. with the help of pallet jacks, forklifts, or related equipment
- Required to stoop, kneel and crouch
- Exposure to cleaning agents



- Indoor warehouse environment
- Frequent exposure to cooler and freezer storage units (freezer/cooler wear provided)
- Moderate to loud noise environment

- Valid Driver's License and Insurance May need to drive to local retail outlets for supplies
